

# ***ARIZONA AVICULTURE SOCIETY BIRD MART***

## **MULTI-SHOW REGISTRATION FORM**

The Arizona Aviculture Society (AAS) Bird Mart will be at the El Zaribah Shrine Auditorium, 552 N. 40<sup>th</sup> Street, Phoenix, Arizona. Shows are currently scheduled for: **Sunday, January 29<sup>th</sup>, 2017; Sunday May 7<sup>th</sup>, 2017; and Sunday, October 15<sup>th</sup>, 2017.** The following guidelines and regulations are set forth by AAS to define Vendor conduct at AAS Bird Mart Events.

Doors will open to the public promptly at 9:00 am and will close at 3:00 p.m. The hall will be open to vendors no later than 7:00 am. All set-up activities must be completed no later than 8:45 AM. The loading doors will be closed at that time. Please allow sufficient set-up time; late arrivals are disruptive to everyone. Bird Mart Vendor identification is required. Two tags are provided per vendor space, with additional tags available upon request. Keep your area clean during the bird mart! **Protect the floor and equipment from damage and clean up your own messes! The club will hold a vendor responsible for any accrued charges for extra cleaning.** Allow only wing-clipped, tame birds to sit outside of cages and only over protective floor covering. If you believe a bird might bite, keep it properly contained.

**Specific Regulations and Pricing Information:**

1. The Bird Mart is limited to birds and bird-related items. The display and/or sale of mammals or reptiles is prohibited.
2. All vendor spaces are approximately 10' wide. Straight spaces include one eight-foot table and two chairs. Corner spaces include two tables and two chairs. Spaces are sold on a first-come, first-served basis. Spaces may only be secured by completion of this agreement and payment of applicable fees. In the event you cancel your rental, refunds will be made only if the space is re-rented. Space assignment is at the sole discretion of AAS. There is no guarantee of assignment of a particular space, either expressed or implied, until written confirmation is issued by AAS.
3. AAS requires birds of questionable health be quarantined a minimum of 30 days prior to the event. **AAS reserves the right to refuse admission to any bird of questionable health.**
4. AAS is not responsible for vendor's city and state retail tax liabilities. You are required to have the appropriate licenses or permits to comply with applicable taxing authorities. For additional information, contact the appropriate tax and licensing office.
5. AAS is not responsible or liable for losses or injuries during the Bird Mart. Vendors are required to take every reasonable precaution to prevent birds from escaping. If a bird escapes, the owner is required to remain after the show to help capture and to take possession of the bird.
6. Parking for vendors will be in an area designated by AAS. Loading and unloading of large vehicles and trailers will be allowed only in areas specified by AAS and the driveways are to be kept clear and passable at all times.
